Common share equivalents received for deferred director fees are fully vested on the transaction date listed above.
- Common share equivalents become payable upon termination of service as a director except for any unvested portion of the Issuer matching contribution.
- Represents common share equivalents acquired by the reporting person in the DDCP through the 25% Issuer matching contribution for the director fees paid to the reporting person during the quarter, based upon the closing price of the underlying shares on the last day of the quarter. Common share equivalents received for dividend reinvestments are fully vested on the transaction date listed above and become payable upon termination of service as a director.
